# MTBA | Simplify MBS ETF

### **FUND OVERVIEW**

**The Simplify MBS ETF (MTBA)** seeks to provide total return, consistent with the preservation of capital and prudent investment management. The fund will invest in mortgage-backed securities (MBS), which provide attractive yields versus comparable US Treasuries while carrying little to no credit risk.

MTBA will focus on buying newer MBS, which have provided higher coupons as well as higher yield to maturity compared to the MBS which comprise the Bloomberg U.S. MBS Index.

### PERFORMANCE REVIEW

MTBA's total return for the quarter was 0.10%, 1.14% ahead of the Bloomberg U.S. MBS Index return benchmark of -1.04%. During the quarter mortgage rates increased slightly with the 30-year Federal National Mortgage Association (FNMA) 30-day commitment rate increasing by 0.35%. The fund's outperformance is largely attributable to the fund's lower sensitivity to movements in interest rates.

Attribution of performance within the fund can be broken out as follows: -0.97% to the fund's To-Be-Announced (TBA) futures position and 1.07% to its holdings of treasuries and cash, net of fees.

### **DEFINITIONS**

**Coupon:** The annual interest rate paid on a bond, expressed as a percentage of the face value and paid from the issue date until maturity.

**Market Price:** The current price at which shares are bought and sold. Market returns are based upon the last trade price.

Mortgage-Backed Securities (MBS): Investment products similar to bonds. Each MBS consists of a bundle of home loans and other real estate debt bought from the banks that issued them. Investors in mortgage-backed securities receive periodic payments similar to bond coupon payments.

**NAV:** The dollar value of a single share, based on the value of the underlying assets of the fund minus its liabilities, divided by the number of shares outstanding. Calculated at the end of each business day.

**SEC 30-Day Yield:** The yield is calculated with a standardized formula and represents net investment income earned by a fund over a 30-day period, expressed as an annual percentage rate based on the fund's share price. The yield includes the effect of any fee waivers and/or reimbursements. Without waivers, yields would be reduced. This is also referred to as the "standardized yield", "30-Day Yield" and "Current Yield". The unsubsidized SEC 30-Day Yield does not reflect the effect of any fee waivers and/or expense reimbursements.

**To-Be-Announced (TBA):** A term that describes the forward-settling of mortgage-backed securities (MBS) trades.
